Carter Lake Sailing Club Lady Wilson Victory Cup 2023 Notice of Race

1. Events:

The Carter Lake Sail Club (CLSC) will conduct its 2023 Lady Victory Cup Regatta at Carter Lake, Larimer County Recreation Area, west of Berthoud Colorado. CLSC is the organizing authority.

2. Rules:

This Regatta will be governed by the 'rules' as defined in "The Racing Rules of Sailing 2021- 2024, except as changed by this NOR, the Sailing Instructions, or the rules of the Larimer County Department of Natural Resources

3. Eligibility and Entry:

The Lady Victory regatta is intended to be a female skippered and crewed regatta. Boats must be skippered by a club member to receive a trophy, but the race is open to all participants. Acceptance of a male as a crew member will be determined by consensus of fully qualified competitors at the competitor's meeting. In lieu of a consensus, a ruling by the Race Committee will be final, and not subject to appeal. Regardless, male crew members are not allowed to helm.

4. Advance Notification:

Advanced Notification is highly encouraged. Boats may indicate their intention to participate by entering their name on the RC, Intent to Race spreadsheet accessible from

the Racing Homepage on the CLSC website, or by e-mail to race@sailcarter.org.

5. Fees:

The Lady Victory Cup Regatta is conducted as a free community service. There is no entry fee. Larimer County Park passes for boats or vehicles will be available at the Marina or park entry stations.

6. Schedule

10:55 Warning signal for the first race, additional races to follow immediately

7. Notices to Competitors

Notices to competitors will be posted on the CLSC notice board on the CLSC club house.

9. Sailing Instructions:

Sailing Instructions; (SI's) will be available on the website under Racing Home and at the competitor's meeting.

10. Regatta Site:

The regatta site will be at the North Pines Area of Carter Lake, Larimer County Recreation Area, west of Berthoud, Colorado.

12. Racing Area and Courses:

Racing area will be shown on the Carter Lake Sailing Club Race Course Chart, available on the web site under "Racing/Racing Home".

13. Scoring:

The low point scoring system of Appendix A of the Racing Rules of Sailing 2021-2024 will be used. All races sailed will be scored.

14. Trophies:

The overall first place finisher will have her name engraved on the Lady Victory Cup trophy.
