# Notice of Race Carter Lake Sailing Club 2025 Columbia Cup Regatta

#### 1. EVENTS

The Carter Lake Sailing Club (CLSC) will conduct the Columbia Cup Regatta at Carter Lake, Loveland CO. Saturday & Sunday May 31 & June 1, 2025. CLSC is the organizing authority.

#### 2. RULES:

This Regatta will be governed by the 'rules' as defined by the 2025-2028 *Racing Rules of Sailing* (RRS) except as changed by this NOR, the Sailing Instructions, and the rules of Larimer County.

#### 3. ELIGIBILITY AND ENTRY:

The event is open to all PHRF rated boats whose skipper was present at the Competitor's Meeting or checks in with the Race Committee on the water. Boats racing shall have a current PHRF certificate issued by the SAIL PHRF committee. Otherwise, a non-negotiable PHRF rating will be assigned by the Race Committee. All boats shall race in one PHRF fleet.

#### 4. FEES

The Columbia Cup Regatta is conducted as a free community service. There is no entry fee. Larimer County Park passes for boats or vehicles will be available at the Marina or park entry stations.
