1. Events:

The Carter Lake Sail Club (CLSC) will conduct its 2020 Jack & Jill Regatta at Carter Lake, Larimer County Recreation Area, west of Berthoud Colorado. CLSC is the organizing authority.

2. Rules:

This Regatta will be governed by the 'rules' as defined in "The Racing Rules of Sailing 2017-2020", except as changed by this NOR, the Sailing Instructions, or the rules of the Larimer County Department of Natural Resources

3. Eligibility and Entry:

The event is open to any boat crewed by one male and one female.

4. Advance Notification:

Advanced Notification is highly encouraged. Boats may indicate their intention to participate by entering their name on the RC, Intent to Race spreadsheet accessible from the Racing Homepage on the CLSC website

5. Fees:

The Jack & Jill Regatta is conducted as a free community service. There is no entry fee. Larimer County Park passes for boats or vehicles will be available at the Marina or park entry stations.

The regatta site will be at the North Pines Area of Carter Lake, Larimer County Recreation Area, west of Berthoud, Colorado.

Racing area will be shown on the Carter Lake Sailing Club Race Course Chart, available at registration.

13. Scoring:

The low point scoring system of Appendix A of the Racing Rules of Sailing 2017-2020 will be used. All races sailed will be scored
